



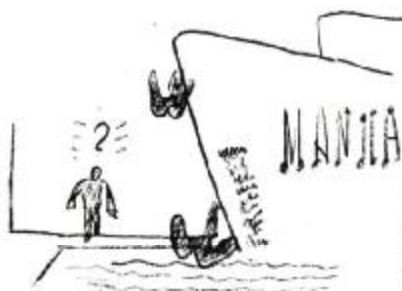

AVISO A LOS RESIDENTES DE JUDIBANA, INQUILINOS DE CASAS PROPIEDAD DE CREOLE

Con frecuencia se reciben solicitudes para instalar en las casas o en los jardines ciertas mejoras que los inquilinos desean ejecutar. Estas solicitudes nos llegan a veces después que el inquilino ya ha comenzado los trabajos, ó hecho compromisos economicos con terceras personas.

Cada inquilino es provisto, al tiempo de asignarle una casa, con la Norma de Mantenimiento y Conservación, donde se especifica el procedimiento a seguir.

Estas mejoras, cuando son anexadas a la construcción ó al terreno, deben ser verificadas por los Ingenieros, y esta revisión no puede hacerse a menos que el inquilino someta planos y especificaciones detalladas. Antes de que se puede considerar el permiso para proceder con las mejoras, se requiere el informe de Ingeniería.

De acuerdo con las Norma de Mantenimiento y Conservación, todos los gastos originados serán de cuenta del inquilino, quien, al tiempo de desocupación deberá:

- 1) remover la mejora a sus expensas, dejando la casa o el jardín en el mismo estado en que la recibió; ó
- 2) dejar la mejora instalada, sin que por ello tenga ningun derecho a reembolso.

Al tiempo de concederse el permiso, el inquilino de la casa puede indicar una de las alternativas antes mencionadas.

En relación a cercas alrededor de la casa, unicamente se concederán permisos para cercas ornamentales que no puedan ser obviamente vistas desde la calle, y previo el estudio de los diseños y especificaciones.

Creemos que la divulgación de este procedimiento ayudará a aquellos inquilinos que deseen instalar cercas o mejoras de algun tipo en sus casas.

DESARROLLO DE LA COMUNIDAD

The foregoing was received in one language only - AND, IS VERY OFFICIAL - What it says, and believe us when we say that we have taken certain liberties with the translation, is:

that the Community Development Group frequently receive requests from tenants (that's YOU) of Company houses for permission to make certain "improvements" in said places of abode and/or gardens, lawns or what have you. To say that these requests are received before-the-fact would be very far from the truth. Generally speaking, they never get there until the work is already started or you have already gotten yourself in hock with somebody else, SAY like buying a swimming pool, Hole and all and then having to move it.

At the time housing is assigned all tenants are provided with the Housing Maintenance Policy which clearly states the procedure to be followed in such cases (IF PEOPLE WOULD ONLY FOLLOW IT)... According to these norms, ALL EXPENSES incurred are for the tenant's personal account, BUT, Before he can make any "improvements", specs and plans must be submitted for Engineering approval... NOW, When he (the tenant) gets ready to disoccupy the house, he'll have to do one of the following:

- 1) Remove (Do AWAY WITH) the "improvement" at his own expense, restoring the house and/or land to its original condition... This could be carried to the extreme of having to buy dirt to fill in a Swimming Pool.

O R

- 2) LEAVE THINGS AS IS, and just quietly LEAVE, VACATE the premises -  
 You (tenant) are not entitled to any monetary benefits for having  
 "improved" your quarters - You enjoyed it.

At the time that permission to "improve" is granted you may elect one of these options. .. As far as fences (outside) are concerned, the same rules apply. Permission is only granted for the erection of ornamental fences, not readily visible from the street.

YOUR FELICAN is such a modern "newspaper" that the Editor went out last week and bought an Income Tax Declaration, one of the newest models, and filled in the blanks for you. Of course everybody got rather confused when the forms given out proved to be of ancient vintage. We checked with the local Tax authorities however and they reassured us that the old forms would be accepted this year. There is no space to indicate the amount of Withholdings made for Complementary Tax but you are required to attach the form G-113 (RC-1), Earnings Statement which has the same information. Of course, if it will make you feel any better you could jot down a statement to this effect: "Impuesto Complementary Retenido - Bs \_\_\_\_\_", somewhere, say at the bottom of the page, BUT IT ISN'T NECESSARY.

IMPUESTO SOBRE LA RENTA - Cualquier persona que ganó más de Bs 11,400,00 durante el año 1961 tiene la obligación de presentar una declaración de rentas. Las formas distribuidas son del tipo viejo y no tienen espacio donde indicar el montante del Impuesto Complementary Retenido. Sin embargo serán aceptados por la Fiscalía del Impuesto sobre la Renta siempre que sean remitidas junto con la forma G-113 (RC-1) Relación de Ganancias.
